Fortunately, the law generally provides protections for board members, as long as the members were acting in good faith. There are a few exceptions to the protections, however, that church board members should keep in mind. These exceptions can be summarized as the "duty of care," "duty of loyalty," and "duty of obedience."

The Agenda for Church Board Meetings below can be used in the church board meetings as a guide to the church board members throughout the meeting in progress. So regardless of whether your church calls its governing board a church council, vestry, session, board of elders or something else, board members are expected to fulfill three duties of public trust. These legal obligations, also known as fiduciary duties, include the Duty of Care, the Duty of Loyalty and the Duty of Obedience.

Out-Reach: The church reaching out to those outside the church. (Evangelism, Missions) In-Reach: The church reaching in to those inside the church. (Encouragement, Fellowship) Up-Reach: The church reaching up by communicating and giving to God. (Praising, Prayer, Worship) Down-Reach: God reaching down by communicating and giving to the church. (Bible Study, Preaching, Teaching, the Holy Spirit)

Church Ministry Structure and Organization

Typical duties include collecting the tithe offerings from the congregation, recording donations, and depositing funds into the correct account. Serving in the role of church treasurer is a special honor and privilege.
